Conditions :

1. Applicants who wish to register should submit a fee of Rs.1,000/= (Refundable deposit of Rs.1,000/= + 15% V.A.T of Rs.150/= = Rs.1,150/= by cash or by a cheque written favour of **Municipal Commissioner, Municipal Council, Ratnapura.**
2. All the applications for the year 2018 , should be sent under registered cover to reach the Municipal Commissioner, Municipal Council, Ratnapura on or before 15.12.2017 by mentioning “Registration of suppliers” on the top left hand corner of the envelop or hand over to the office.
3. Quotations will be called from the selected applicants. However, council reserve the right to call quotations from any source.
4. If you wish to register for few items, you have to pay the relevant fee for each item and the relevant item numbers should have written clearly in the application.
5. The Procurement Committee has authority to register or not to register the suppliers.
6. The names of the Suppliers who do not kindly submit their quotations or who are unable to supply the goods and services on time or who supply the goods and services and repairing and maintenance activates not in accordance with the specifications will be write-off from the name list.
7. The registration of suppliers who request to do payments even before supplying of goods will be cancelled and at least 30 days credit facility should be given to the council.
8. The Procurement Committee have a right to reject the quotations which are exceeding the value recommended by the District Price Deciding Committee.
9. The Applications which are not duly completed will rejected.
10. The Applications could be obtained by personally call over at this office.
